**Incentives and Support for Ohioans** 

Conversion Facilities Tax Exemption
The State of Ohio provides tax exemptions for qualified facilities for energy conversion, solid waste energy conversion or thermal efficiency improvements. www. odod.state.oh.us/cdd/oee/c\_i\_cfe.htm.

Energy Loan Fund (ELF) The Energy Loan Fund is the financing portion of the Ohio Advanced Energy Fund.\* It provides an incentive for energy efficiency and renewable energy choices by reducing the interest on standard bank loans from participating banks for qualifying Ohio residents. The Fund, which began featuring grants for commercial and industrial projects in 2004, is administered by the Office of Energy Efficiency within the Ohio Dept. of Development. www.odod.state.oh.us/ cdd/oee/energy\_loan\_fund.htm

Federal Tax Credits for Solar and Energy Efficiency The Energy Policy Act of 2005 (EPACT) offers federal tax credits for solar and energy efficiency measures beginning January 1, 2006 and extended through the end of 2008. For a guide of these federal tax credits for solar, visit www.seia.org.

- Residential Allowable tax credit is 30 percent of a qualified solar electric, solar water-heating and fuel cell systems up to \$2,000.
- Business Allowable tax credit is 30 percent for solar and fuel cells, and 10% for stationary micorturbines.

Net Metering/Simplified Interconnection If your system is connected to the grid in an investor-owned utility (AEP, First Energy, Duke, DP&L), then the utility

is required to net meter any excess electricity produced from your renewable energy system (yes - the electric meter spins backwards!) www.puco. ohio.gov/puco/consumer.

Ohio Air Quality Development Authority (OAQDA)

The OAQDA can offer tax exemptions (sales and use tax, and corporate franchise tax) for renewable energy projects. While the majority of the projects come from business and institutional customers, residential applications are eligible and cost-effective if the project is of substantial size. www.ohioairquality.org
